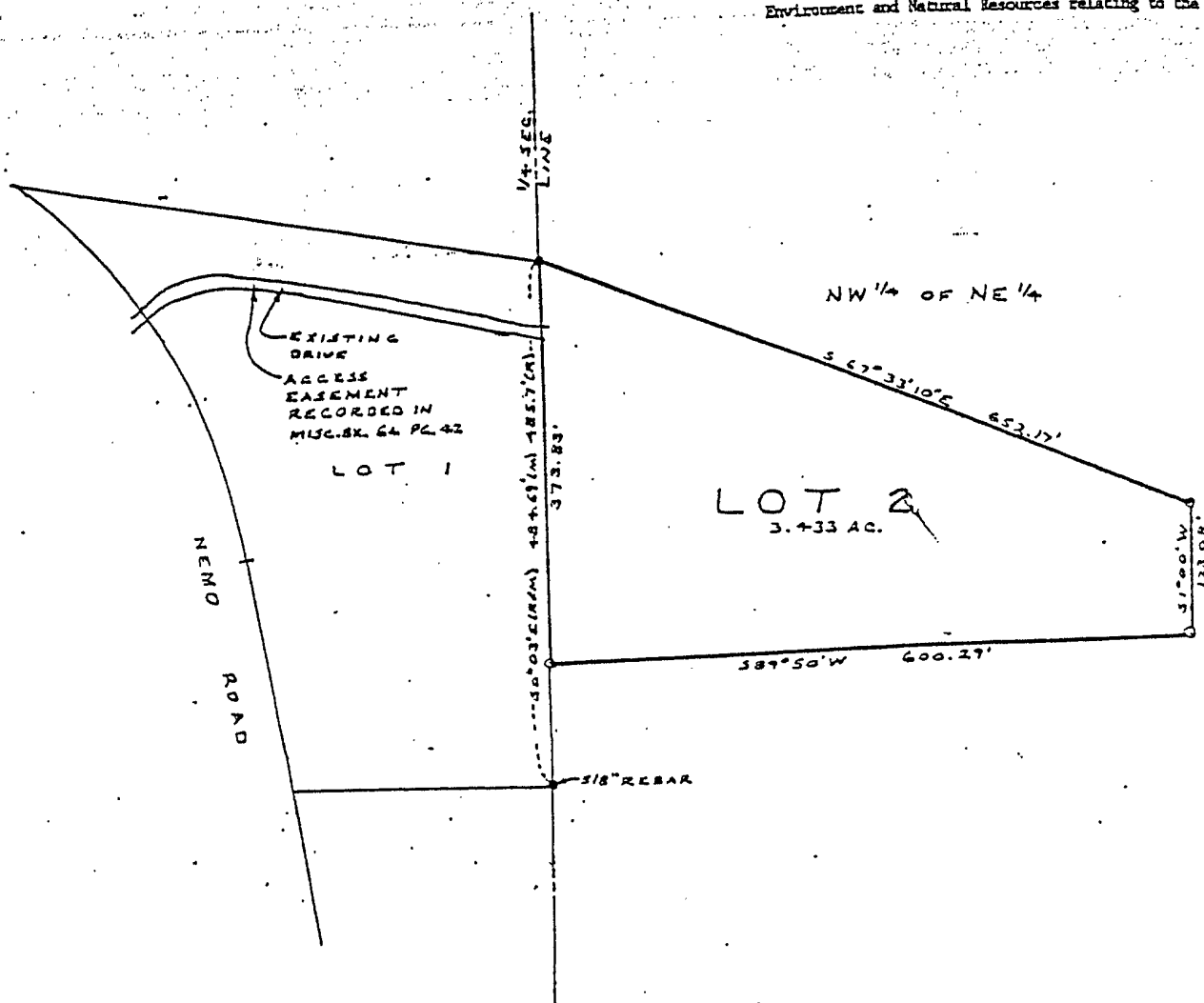

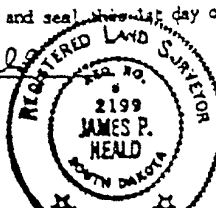

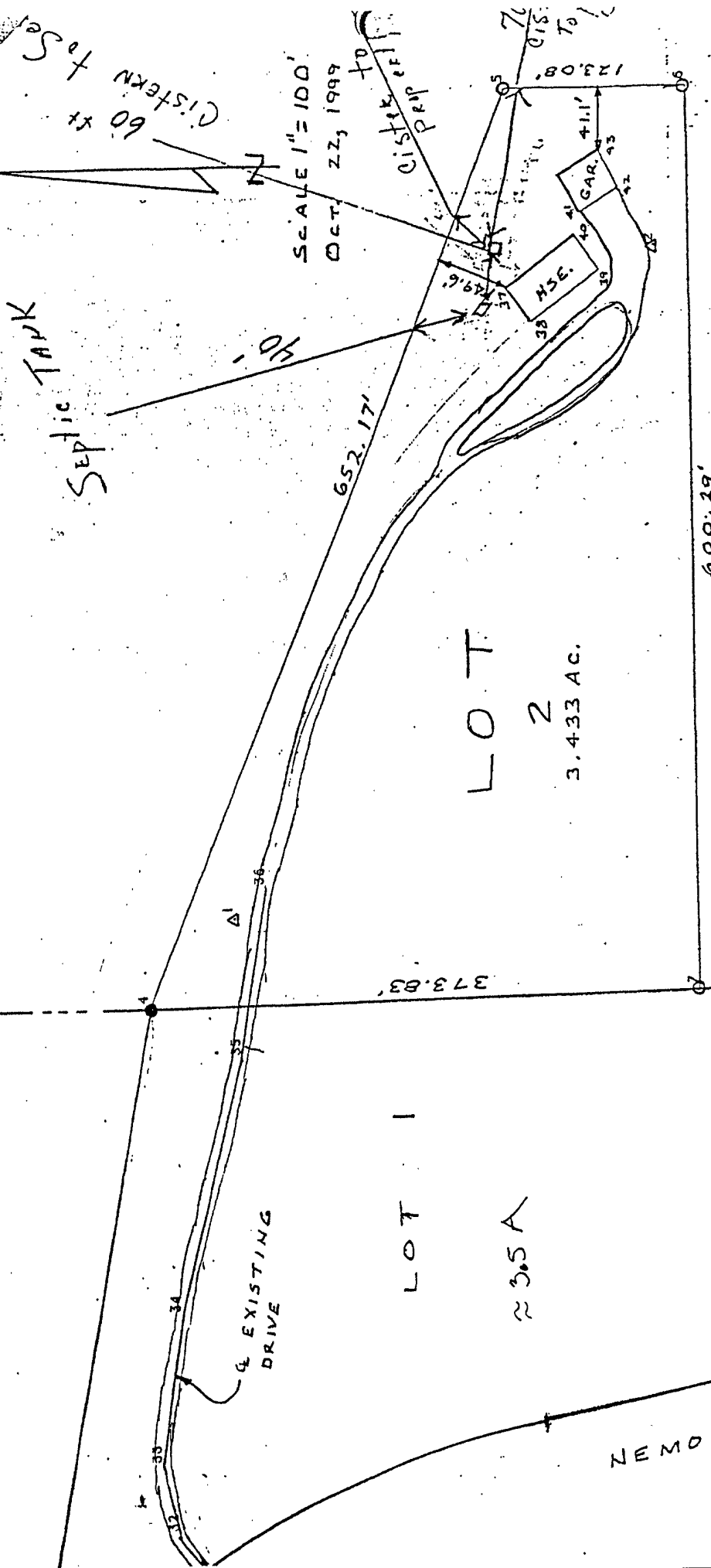


SEPTIC TANK
