

RESOLUTION OF NECESSITY
FOR
BLOCK 7 ALLEY PAVING (MILLARD SUBDIVISION) PROJECT ST00-991

BE IT RESOLVED by the City of Rapid City as follows:

The City Council hereby declares the necessity of paving approximately 580 linear feet of alley as located in Block 7 of the Millard Subdivision.

The general nature of the project is as set forth above, and reference for detail is hereby made to the drawings and specifications that will be prepared by/for the Engineering Department and placed on file with the City Finance Officer.

The estimated costs of the project are \$20,000 of which 60% will be assessed to the benefiting properties on the basis of equal benefit.

The method of apportionment is as follows:

The above affected property owners will be assessed 60% of the cost of the alley paving improvements on a 'equal benefit' basis. The total assessed cost is estimated to be \$13,200.
