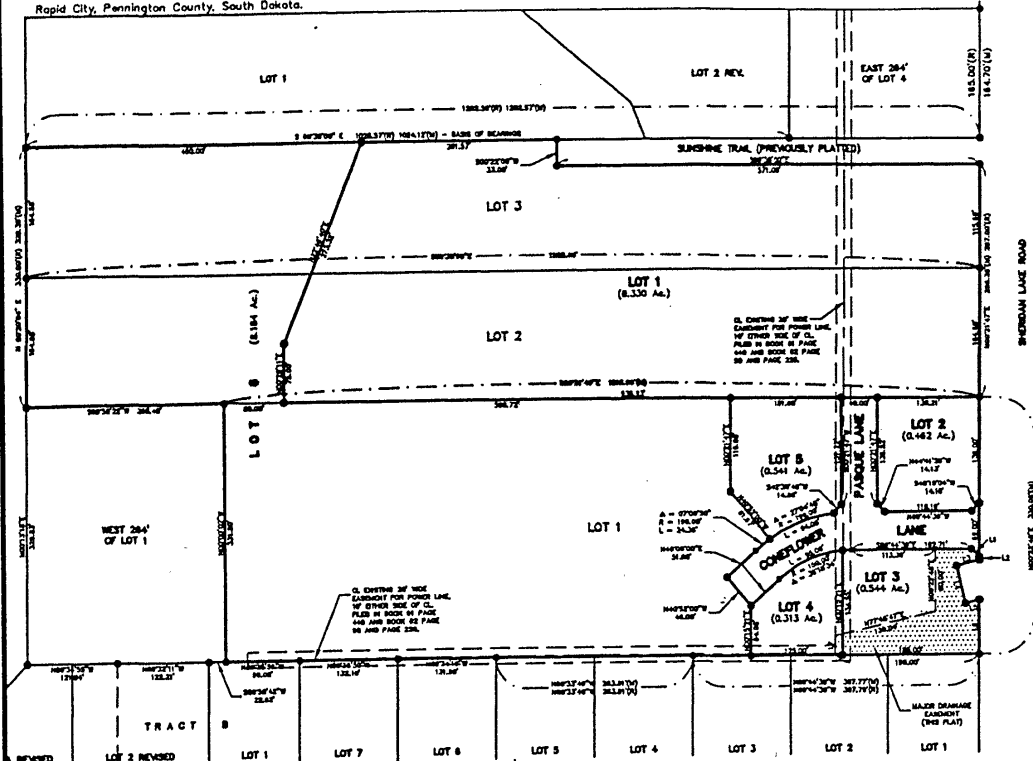

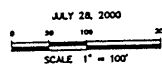
Plat of Lots 1 through 6 of Sunshine Hills Subdivision and
