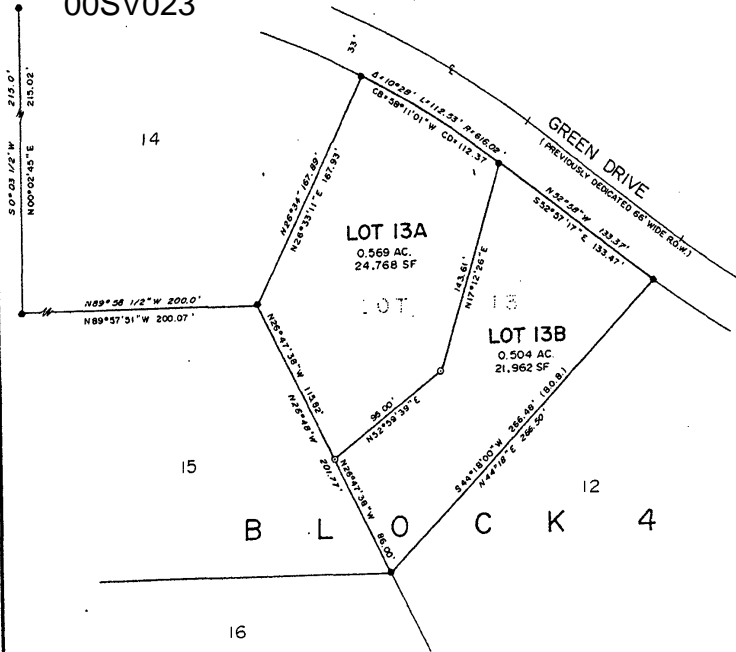
Utility and Minor Drainage Easements - 8' wide on the interior side of all side and rear lot lines.
