Dear Mr. Mohr,

I have received and reviewed your application for a city license as private security for the Outer Limits Bar. I am sorry but it will be my recommendation that this license not be issued.

In conducting an electronic check it was revealed that you have an extensive record that you intentionally minimized on your application. You also failed to disclose four DUI arrests. According to the Rapid City ordinance under security guards 5.52.030 the applicant is responsible for disclosing, to the best of his knowledge, any arrest records and convictions.

Since reliability, integrity and trustworthiness are integral parts of any security function, it is my determination that this license should not be issued. I must inform you that I do not have the last say in this situation.

If you feel aggrieved by my decision, please contact Mr. James Preston the City Finance Officer and ask for a hearing on this matter. You must make that request within 10 days.

After a hearing is requested we will meet before the Rapid City Common Council at which time you will have an opportunity to explain why your lack of truthfulness and your arrest record should not be held against you. I will explain why I believe they should not issue this license. The Rapid City Common Council has the final say in this situation.

If you should have any questions please contact me. Otherwise, please be advised that every day you operate as a security officer without a license, is a separate offense.

On October 9, 2000 Mr. Mohr submitted an application to be licensed as private security and work for the Outer Limits Bar in Rapid City, SD. Mr. Mohr completed the city application and disclosed four speeding violations and one accident. Mr. Mohr made no indications as to whether or not he's ever been arrested or convicted of any crimes.

On October 12, 2000 a criminal records check was completed on Mr. Mohr in the states of South Dakota, Montana, and Nebraska. The following records were discovered. There was no criminal records found in Montana or Nebraska, but the following records were found under South Dakota State Records.


