## **MEMORANDUM**

- SUBJECT: Assessment Roll for Farlow Avenue Water Main Extension Project No. W99-844
- DATE: November 8, 2000

Submitted herein is the Assessment Role for costs associated with the above referenced project. I recommend that \$26,646.74 be accepted as the final construction cost of the project and that a total of \$17,794.70 be assessed to the property owners listed herein in accordance with the Resolution of Necessity.

The Resolution of Necessity reads in part, "...The estimated assessed costs of the project are \$15,800.00 will be assessed to the benefiting properties on the basis of use. The recorded ownership and estimated costs for the properties are listed on the attached property ownership list.

"These estimated assessed costs include six percent (6%) engineering fees and five percent (5%) fiscal fees. Interim construction fees to be determined by the Finance Officer shall be included in the project cost, which will be assessed to the benefitting properties. ..."
