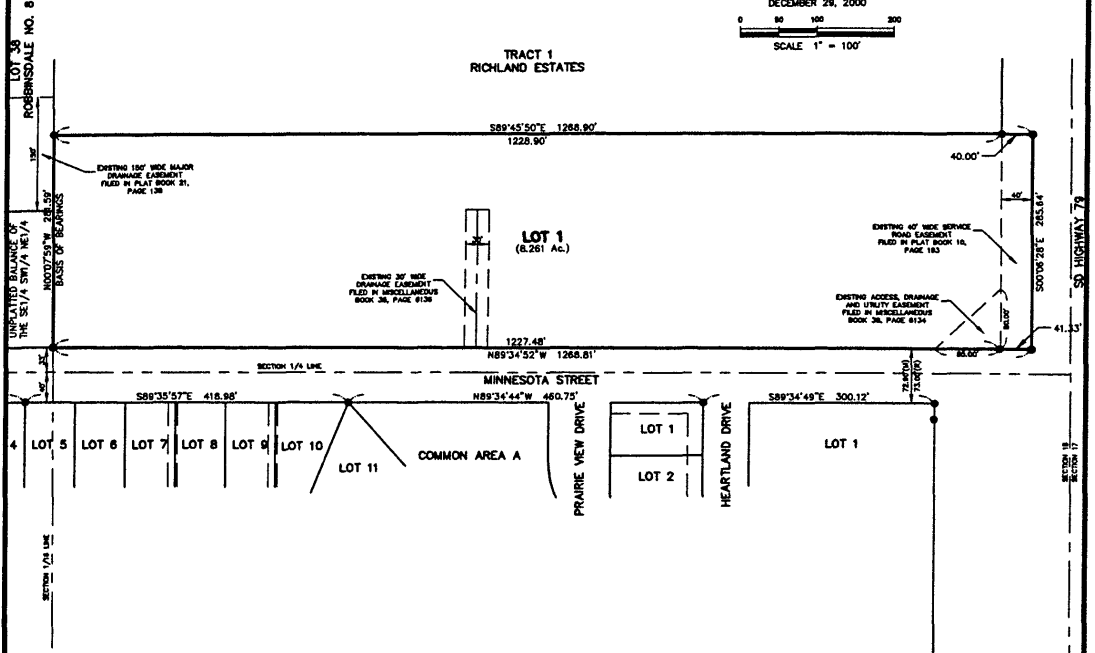
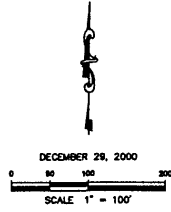


Plat of Lot 1 of Heartland Subdivision
