## **SUPPLEMENTAL APPROPRIATION NO. 6 FOR 2001**

1. Recreation Enhancements 2012 - \$2,300,000. Reduce appropriation for Community Centers in 2001 from \$2,750,000 to \$210,000 (Council 7/16), increase funding for skateboard park by \$55,000 (Council 5/7 and 8/6), increase funding for ballfield lighting by \$60,000 (Council 8/6) and move the \$5,000,000 appropriation for Roosevelt Park Ice/Recreation from Recreational Ice to Recreation Enhancements (See Item 5).
2. Infrastructure Improvements – (\$2,265,500). Eliminated to fund other purposes (Council 6/18)
3. Sioux Park Recreational Complex - \$30,000. Additional excavation necessary to complete Phase III (Council 8/6)
4. Special Projects - \$1,573,000. \$300,000 for Wastewater Reclamation Facility (Council 6/18), \$500,000 for Dahl Fine Arts Project (Council 6/18), \$300,000 for Golf Club House (Council 8/6), \$923,000 for Library Project (Council) 8/6 plus \$650,000 donated funds).
5. Recreational Ice – (\$5,000,000). To Recreation Enhancements. (See Item 1)
