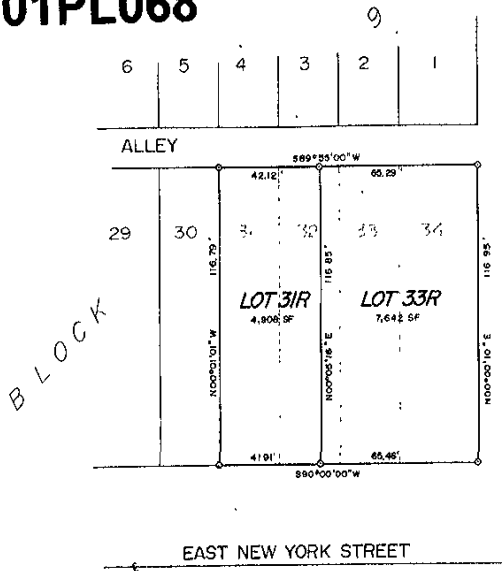


PLAT OF LOT 31R AND LOT 33R IN BLOCK 9 OF BLAKE'S ADDITION
