

TOTAL LEGAL

Site survey of the N1/2 of Lot 4 and all of Lots 5 and 6 of Lot A of the SE1/4S1/4 of Section 6, T.1N., R.BE., B.H.M. in the city of Rapid City; and the East 44 feet of Lats 5, 6, 7 and 8, Block 1 of Radio Towers Subdivision in the city of Rapid City; together with that part of the alley vacated by a resolution recorded September 14, 1962, Book 80 of misc. records on Page 442, which adjoins Lots 5, 6, 7 and 8 Block 1, of Radio Towers Subdivision, Pennington County, South Dakota.

SITE LEGAL

A portion of land situated in the East 44 feet of Lot 7, Block 1 of Radio Towers Subdivision in the city of Rapid City, Pennington County, South Dakota, more particularly described as follows:

Commencing at the Northwest Corner of the East 44 feet of Lot 8, Block 1 of said Radio Towers Subdivision; thence S.01'58'35"W. along the West line of the East 44 feet of Lots 8 and 7 of said Radio Towers Subdivision a distance of 97.43 feet; thence S.88'01'25"E. a distance of 11.05 feet to the True Point of Beginning of this easement description; thence S.88'39'47"E. a distance of 4.00 feet; thence S.01'20'13"W. a distance of 15.00 feet; thence N.88'39'47"W. a distance of 4.00 feet; thence N.01'20'13"E. a distance of 15.00 feet to the Point of Beginning.

PARKING AND CIRCULATION EASEMENT

Also together with a parking and circulation easement 20 feet wide upon a portion of the East 44 feet of Lots 7 and 8, Block 1 of Radio Towers Subdivision in the city of Rapid City, together with that port of the alley vacated by a resolution recorded September 14, 1962, Book 80 of misc. records on Page 442, which adjoins Lots 5, 6, 7 and 8 Block 1, of Radio Towers Subdivision and a portion of Lot 6 of Lot A of the SE1/4S1/4 of Section 6, T.1N., R.8E., B.H.M. in the city of Rapid City, Pennington County, South Dakota, the centerline of which is more particularly described as follows:

Commencing at the Northwest Corner of the East 44 feet of Lot 8, Block 1 of said Radio Towers Subdivision; thence S.88'01'25''E. a distance of 159.00 feet to the Northeast corner of said Lot 6; thence along the East line of Lot 6 S.01'58'35'W. a distance of 27.72 feet to the True Point of Beginning of this centerline description; thence N.88'02'50"W. a distance of 79.12 feet; thence S.40'46'03"W. a distance of 89.34 feet to the terminus of this centerline description. The South line is to be shortened so as to terminate on the North face of an existing building.
