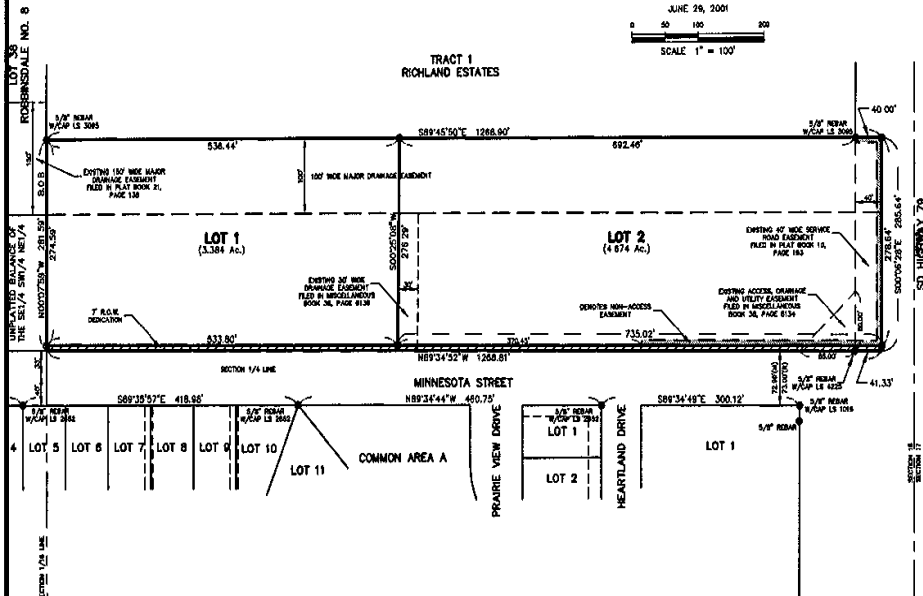


Plat of Lot 1 and Lot 2 of Bies Subdivision
