A portion of Lot Two (2) of the Southeast Quarter of the Northeast Quarter (SE¹/₄NE¹/₄) of Section Three (3), Township One North (T1N), Range Seven East (R7E) of the Black Hills Meridian, Pennington County, South Dakota, as shown on Exhibit "A", attached hereto.

This easement shall include the right to enter upon the easement property for the purpose of constructing, installing, operating, inspecting, and maintaining a public water and sewer main.
