The Subsidy Committee recommends that the City amend the Community Development Block Grant Final Statement of Activities to provide increased funding for the purpose of providing additional buildable lots for affordable housing for homeownership.

The additional funding is from unprogrammed CDBG funds available on the City's letter of credit balance with HUD. Additionally, the Subsidy committee recommends decreasing the Rehabilitation line item by \$25,000 and adding to the Rapid City Community Development Corporation. This additional funding will allow the RCCDC the opportunity to acquire an additional nine (9) lots on which to either stick build affordable housing or provide Governor's Houses for eligible applicants.

Several months ago, I spoke with the Salvation Army about the need for additional funding in light of the Federal Beef fire. The Salvation Army has been providing services to persons who were employed by Federal Beef, and the resources are very low. I visited with Mayor Munson and other subsidy committee members about providing an additional \$10,000 to the Salvation Army for

services to low income residents. Included in this amendment is allocating an additional \$10,000 to the Salvation Army and deducting that amount from the administration line item. I can reduce the administration line item since I have had the Administrative Assistance position vacant since March 22.

I request Council approval on Amendment #1 to the FY 2002 CDBG Final Statement of Activities and Projected Use of Funds.

- Expand homeownership opportunities for low income persons.
- 2) Provide rehabilitation of existing owner/occupied dwelling units;
- 3) Increase the supply of decent affordable housing by providing financial assistance to developers;
- Increase the capacity of non profit organizations to serve low income residents by providing for the expansion of existing public facilities;
- 5) Assist direct service providing organizations with the financial resources to increase the services currently provided.
- 6) Upgrade the public infrastructure to preserve quality of life in our community.

The FY2002 projects provide the financial assistance to accomplish the strategies outlined. The funding provided through the City's CDBG program helps continue vital services to low income residents; provides an opportunity to become a homeowner; assists with rehabilitation of a low income persons home; and assists with upgrading public facilities that provide services to the homeless and the low income residents in our community.
