### **RESOLUTION OF NECESSITY**

#### FOR

### BLOCK 31 FLORMANN AND BLOCK 32 SUNNYSIDE ADDITION ALLEY PAVING

#### PROJECT NO. ST02-1233

BE IT RESOLVED by the City of Rapid City as follows:

The City Council hereby declares the necessity of paving approximately 930 lineal feet of alley as located in Block 31, Flormann Addition and Block 32, Sunnyside Addition.

The general nature of the project is as set forth above, and reference for detail is hereby made to the drawings and specifications that will be prepared by the Engineering Department and placed on file with the City Finance Officer.

The estimated costs of the project are \$32,000 which 60% (\$22,000) will be assessed to the benefiting properties on the basis of equal benefit.

The recorded ownership and estimated costs for the properties are listed on the attached property ownership list.

These estimated assessed costs include six percent (6%) engineering fees and five percent (5%) fiscal fees. Interim construction fees to be determined by the Finance Officer shall be included in the project cost, which will be assessed to the benefiting properties.
