### **OVERVIEW**

Recently the City of Rapid City requested a quote for web site hosting services for the web site, [www.rcgov.org](http://www.rcgov.org). The following is a proposal from Frankenfeld Associates to provide web site hosting for the City of Rapid City.

### **ASSUMPTIONS**

The following assumptions were made during the creation of this proposal.

- The site being hosted will be very similar to the current site that exists for [www.rcgov.org](http://www.rcgov.org).
- The content of the site will be maintained by personnel employed by the City of Rapid City, using products similar to DreamWeaver, and will be accessed using the FTP protocol.
- Approximately 25 different users will need to be able to update portions of the web site, but may or may not have access to update the entire site.
- Approximate disk space required for the current web site is approximately 390 megabytes.
- The City of Rapid City will set up and maintain e-mail accounts linked to the site.
- Two additional domain names are also pointed to the City of Rapid City web site: 1) [rcgov.net](http://rcgov.net) and 2) [rcgov.com](http://rcgov.com).
