RECOMMENDATION:

Staff recommends that the Preliminary and Final Plat be approved with the following stipulations:

Engineering Division Recommendations:

- 1. Prior to Preliminary Plat approval by the City Council, the design plans shall be revised in accordance with the red line comments;
- 2. Prior to Final Plat approval by the City Council, the applicant shall provide documentation of a sanitary sewer easement crossing Lot 6 of Grimm Addition for a sanitary sewer main serving Lot 3 of Grimm Addition;
- 3. Prior to Final Plat approval by the City Council, the plat shall be revised to include a non-access easement along the entire Creek Drive frontage and along the Viewfield Avenue frontage for a distance of 50 feet from the intersection of Creek

Fire Department Recommendations:

- 4. That all requirements of the Uniform Fire Code shall be continually met;
- 5. Prior to the start of any building construction, fire hydrants shall be installed and operational;
- 6. Prior to the start of any building construction, all weather access roads shall be constructed to the building sites. Dead-end access roads in excess of 150 feet in length shall include the provision of a cul-de-sac or turn-around area that complies with all requirements of the Uniform Fire Code and the Rapid City Street Design Criteria Manual;
- 7. Prior to the start of any building construction, street signs shall be posted. The street signs may be constructed of temporary material initially. Prior to issuance of a Certificate of Occupancy, permanent street signs shall be posted;
- 8. Prior to issuance of a Certificate of Occupancy, the facility(s) addresses shall be posted. Said numbers shall be a minimum of seven inches in height and displayed on a contrasting background;
- Prior to issuance of a Certificate of Occupancy, the facility(s) addresses shall be posted. Said numbers shall be a minimum of seven inches in height and displayed on a contrasting background;

Pennington County Register of Deeds Recommendation:

10. Prior to Final Plat approval by the City Council, the applicant shall revise the plat to include "in Grimm Addition" to the formerly statement;

Air Quality Division Recommendations:

11. An Air Quality Construction Permit shall be obtained if more than one acre of surface area is disturbed prior to the issuance of any building permits or grading permits;

Urban Planning Division Recommendations:

- 12. Prior to Preliminary Plat approval by the City Council, subdivision improvement estimates shall be provided for review and approval;
- 13. Prior to Final Plat approval by the City Council, the subdivision inspection fees shall be paid; and,
- 14. Prior to Final Plat approval by the City Council, the applicant shall post surety for the required improvements along the west 115 feet of Viewfield Avenue that have not been completed. For the balance of the Viewfield Avenue frontage subdivision improvements, the applicant shall either enter into an agreement with the City to pay now for the required improvements which the City will install at a later date or post a separate surety bond.
- GENERAL COMMENTS: (Updates to the staff report are shown in bold.) This item was continued from the December 5, 2002 Planning Commission meeting. The applicant has submitted this Preliminary and Final Plat request to plat a currently unplatted balance of land that is located at the intersection of Creek Drive and Viewfield Avenue. The property is 2.31 acres in size and is void of any structural development. Creek Drive, where it abuts the

subject property is a gravel drive. The Viewfield Avenue right of way abuts the property on the north and has not been constructed.

<u>STAFF REVIEW</u>: Staff has reviewed the proposed Preliminary and Final Plat and noted the following major concerns:

Road Improvements: As mentioned previously, Creek Drive is not improved along the frontage of the subject property. In addition, the right of way for Viewfield Avenue, along the north side of the property, has not been improved. The applicant has submitted construction plans for the required improvements along both Viewfield Avenue and Creek Drive; however, the Engineering Division has noted that the plans did not include a major drainage ditch crossing for the drainage ditch located near the northeast corner of the property. The adopted Perrine Drainage Basin Design Plan identifies the location of a detention pond on the north side of Viewfield Avenue and a channel through the northeast corner of the subject property. However, because the City does not have the funding to complete the detention pond and drainage ditch improvements at this time, the Engineering Staff is recommending that the applicant complete the preliminary design plans for the extension of Viewfield Avenue along the entire frontage of the subject property and provide final design plans for that portion of Viewfield Avenue providing access to the subject property. The applicant will be required to cover the costs for the construction of the required improvements along the entire frontage of Viewfield Avenue; however, construction of Viewfield Avenue along the entire frontage of the subject property cannot be completed at this time. Staff is recommending that prior to Final Plat approval by the City Council the applicant either complete the construction of or post surety for the required improvements along the west 115 feet of Viewfield Avenue. For the balance of the Viewfield Avenue subdivision improvements, the applicant has the option of either entering into an agreement with the City to pay now for the required improvements which the City will install at a later date or post a separate surety bond.

On December 9, 2002 the applicant's engineer submitted revised design plans for Creek Drive and Viewfield Avenue. The Engineering Division has reviewed the plans and returned the red lined plans for minor revisions. A revised plat was also submitted on December 9, 2002 that included a major drainage easement for the drainage channel identified in the adopted Perrine Drainage Basin Design Plan. The Engineering Division has reviewed the information submitted and approved the major drainage easement as shown.

Right Of Way: Creek Drive is identified on the adopted Major Street Plan as an arterial road requiring a minimum 100 foot right of way width. Currently, that portion of the Creek Drive right of way adjacent to the subject property is 60 feet wide. Staff is recommending that 20 feet of additional right of way be dedicated as part of the platting of this property. Another 20 feet of right of way will be obtained when the property on the west side of Creek Drive is platted. On December 9, 2002 the applicant submitted a revised Preliminary and Final Plat showing the dedication of 20 feet of right of way along the Creek Drive frontage.

<u>Utility Extension</u>: The Engineering Division has also noted that water and sanitary sewer mains must be extended to the north property line along Creek Drive and a water line

installed along the Viewfield Avenue frontage. The design plans submitted with this Preliminary and Final Plat request did not include the extension of the water main in either the Creek Drive or Viewfield Avenue right of way. Staff is requesting that the applicant revise the design plans to include the extension of the water main within the Creek Drive and Viewfield Avenue rights of way. The Fire Department has indicated that depending on the future development of the property the installation of fire hydrants will be required based on the applicable Uniform Fire Codes. On December 9, 2002, the applicant's engineer submitted the requested design plans for the extension of the water main in the Viewfield Avenue and Creek Drive right of way. The Engineering Division reviewed the plans and returned red lined plans to the applicant's engineer for minor revisions.

The applicant has indicated that proposed Lot 4 will be served by an existing sanitary sewer line located in the Viewfield Avenue right of way and that existing Lots 3 and 6 of Grimm Addition are served by an existing sanitary sewer main that crosses Lot 6. The Engineering Division has requested that the applicant submit evidence that a utility easement has been filed with the Pennington County Register of Deeds for the existing sanitary sewer line crossing Lot 6 and that the easement is dedicated for a sanitary sewer main serving Lot 3. As of December 12, 2002 the applicant has not submitted the requested documentation of a sanitary sewer easement.

Non-Access Easements: As mentioned previously, Creek Drive is classified as an arterial street on the adopted Major Street Plan while Viewfield Avenue is considered a local street. The Street Design Criteria Manual requires that if a property has frontage on more than one street, access to the property shall be taken from the lesser order street frontage. The Engineering Staff is recommending that the applicant revise the Preliminary Plat to include a non-access easement along the entire Creek Drive property line and along the Viewfield Avenue property line for a distance of 50 feet from the intersection of Creek Dive and Viewfield Avenue. As of December 12, 2002, the applicant has not submitted the revised Preliminary and Final Plat showing the requested non-access easements.
