

AMENDMENT #2 TO STATE OF SOUTH DAKOTA
HISTORICAL PRESERVATION ALLOCATION AWARD
BETWEEN
STATE HISTORICAL PRESERVATION OFFICE, OFFICE OF HISTORY
AND
RAPID CITY HISTORIC PRESERVATION COMMISSION
PROJECT 46-02-021

THIS AMENDMENT, made effective the January 30, 2003, by and between the State of South Dakota acting herein through the Office of History, State Historical Preservation Office (hereinafter called the State) and the Rapid City Historic Preservation Commission (hereinafter called the Subgrantee) pursuant to the provisions of SDCL 1-19A.

-WITNESSTH-

WHEREAS, the State has heretofore awarded an allocation to the Subgrantee to complete a National Register Nomination;

WHEREAS, the Subgrantee has determined that the nomination is not possible and a new project must be instated;

WHEREAS, the State agrees that such a change will be beneficial to the State in terms of receiving completed product;

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants and agreements herein contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree to amend the Allocation Award as follows:

1. That the commission hire a contractor to restore historic windows and door from the First Baptist Church;
2. That the \$2,500 for the nomination be used for the restoration project;
3. That \$2,500 cash match will be provided by the Feigel House Foundation for said project;
4. When complete, the restored items be put on display in a prominent location to explain good preservation


~~Except as hereby modified, the aforesaid Allocation Award shall otherwise be in full force and effect and is hereby expressly approved, ratified, and confirmed.~~




