

**AMENDMENT TO THE JOINT RESOLUTION  
ESTABLISHING GEOGRAPHIC INFORMATION SYSTEM (GIS)  
STANDARD PRODUCTS AND DATA PRICING LIST**

**WHEREAS** on May 5, 1998, the Rapid City Council and the Pennington County Board of Commissioners approved a Joint Resolution establishing a Land Information System (LIS) Task Force to coordinate and oversee the joint Pennington County-Rapid City Geographic Information System (GIS); and

**WHEREAS** on March 19, 2001, the Rapid City Council and the Pennington County Board of Commissioners adopted a GIS Information Policy for Rapid City and Pennington County, South Dakota, that promotes the free and open flow of information; and

**WHEREAS** the GIS Information Policy identifies that the LIS Task Force may make available for sale standard products and may establish a standard products list with product pricing and availability; and

**WHEREAS** on May 16, 2001, the LIS Task Force recommended for approval the attached GIS Standard Products and Data Pricing List for digital data, hard copy data and mapping services for digital information; and

**WHEREAS** on June 18, 2001, the Rapid City Council and the Pennington County Board of Commissioners approved a GIS Standard Products and Data Pricing List for digital data, hard copy data and mapping services for digital information; and

**WHEREAS** on September 25, 2002, the LIS Task Force recommended for approval amendments to the adopted GIS Standard Products and Data Pricing List for digital data, hard copy data and mapping services for digital information.

**WHEREAS** on May 23, 2003, the LIS Task Force recommended for approval amendments to the adopted GIS Standard Products and Data Pricing List for the cost of maps produced using the RapidMap interface at Public Access Computers.

**NOW, THEREFORE, BE IT RESOLVED** by the City of Rapid City and the County of Pennington that the GIS Standard Products and Data Pricing List has been revised and the attached revised GIS Standard Products and Data Pricing List is hereby established for digital data, hard copy data and mapping services for digital information developed through the Pennington County-Rapid City GIS Division.

**BE IT FURTHER RESOLVED** that the Joint Resolution adopted on June 18, 2001 shall remain in full force and effect as modified by this Resolution.
