SUBLEASE

This sublease agreement made as of the _____ day of ______, 2003, by and between Gikling and Wilson, Inc., DBA Black Hills Harley-Davidson ("Subleasor") and the City of Rapid City, the sublessee, hereinafter called the "City."

WHEREAS the State of South Dakota, South Dakota Department of Transportation and Gikling and Wilson, Inc. (referred to in this agreement as "Subleasor") entered into a certain indenture of Lease No. 1383 on the 16th day of November, 1990, and extended said lease to the 1st day of November, 2007;

WHEREAS the City of Rapid City wishes to sublease from Subleasor a portion of property owned by the State and leased to the Subleasor for the purpose of allowing general access parking to the public;

NOW, THEREFORE, in consideration of the mutual covenants herein made, to be kept and performed by the respective parties, the Subleasor and the City hereby agree as follows:

- 1. The Subleasor hereby subleases to the City all that part of the premises of said State of South Dakota's station ground property containing 49,413 square feet, more or less, as shown in red on the plat dated September 18, 2002, attached hereto and made a part hereof.
- 2. The City, as sublessee, shall use said premises exclusively for the purpose of general parking for public access.
- 3. This sublease shall be effective immediately upon execution of this agreement and shall expire on November 1st, 2007, at which time the underlying lease agreement between the State of South Dakota and Subleasor terminates. On this date this sublease shall expire and be of no further force or effect unless the parties shall specifically and mutually agree otherwise, in writing. This sublease shall be terminable by either party upon ninety (90) days written notice to the other party.

4. As consideration for the granting of this sublease the City shall pay to the Subleasor the sum of One Dollar (\$1.00).
