## **Recitals**

WHEREAS, the Church has previously granted to the City a temporary construction

easement over and across the following described real property:

A strip of land ten feet (10') in width over and across Lot Sixteen (16) of Block Thirty-one (31) of the Nowlin and Wood Addition, in the North Half of the Northwest Quarter ( $N\frac{1}{2}NW^{\frac{1}{4}}$ ) of Section Thirty-one (31), Township Two North (T2N), Range Eight East (R8E) of the Black Hills Meridian, Rapid City, Pennington County, South Dakota;

WHEREAS, the Church requests payment in the amount of Five Hundred

Street/East Anamosa Street construction project have been resolved to their satisfaction.
