RE: Historic Preservation Commission Grant

Reallocation of Project Funding

The Historic Preservation Commission requests approval of Amendment #1 to State of South Dakota Historical Preservation Allocation Award for Preservation Project SD-04-20. The requested reallocation would allow Historic Preservation Commission members to attend a Cultural Preservation Conference in Rapid City on October 8-10, 2004, sponsored by Preserve South Dakota.

The amendment will reallocate funding in the amount of \$308 from the Workshop line item to the Education line item in the 2004-2005 CLG Grant.

**THIS AMENDMENT,** made effective the 3 September 2004, by and between the State of South Dakota acting herein through the Office of History, State Historical Preservation Office (hereinafter called the State) and the Rapid City Historic Preservation Commission (hereinafter called the Subgrantee) pursuant to the provisions of SDCL 1-19A.

#### WITNESSTH:

**WHEREAS**, the State has heretofore awarded an allocation to the Subgrantee to complete a public workshop;

**WHEREAS**, the State has heretofore agreed to amend the allocation to allow the movement of \$308 from Workshop to Training;

**WHEREAS**, the State agrees that such a change will be beneficial to the State in terms of fulfilling the purposes of the grant;

**NOW, THEREFORE**, in consideration of the foregoing and the mutual covenants and agreements herein contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree to amend the Allocation Award as follows:
