RESOLUTION OF NECESSITY FOR BLOCK 8 ALLEY PAVING (WEST BOULEVARD ADDITION)

BE IT RESOLVED by the City of Rapid City as follows:

The City Council hereby declares the necessity of installing approximately 250 lineal feet of sanitary sewer and paving approximately 600 lineal feet of alley as located on in Block 8 of the West Boulevard Addition

The general nature of the project is set forth above, and reference for detail is hereby made to the drawings and specifications that will be prepared by the Engineering Department and placed on file with the City Finance Officer.

The estimated costs of the project are \$39,000 which 60% (\$27,000) will be assessed to the benefiting properties on the basis of equal benefit for the sanitary sewer and on the basis of front footage for the street paving improvements.

The recorded ownership and estimated costs for the properties are listed on the attached property ownership list.

These estimated assessed costs include six percent (6%) engineering fees and five percent (5%) fiscal fees. Interim construction fees to be determined by the Finance Officer shall be included in the project cost, which will be assessed to the benefiting properties.
