Attached for your review and approval is Amendment #05-002 to the 2005-2009 Transportation Improvement Program. This amendment provides the State Archaeological Research Center with a mobile storage system to house historic and prehistoric Archaeological artifacts found and evaluated on SDDOT projects. The artifacts and archaeological information discovered on SDDOT projects are available to the public and researchers throughout the country via the Smithsonian Institution.

The proposed project is fully funded through the State of South Dakota. The estimated cost for the mobile storage system is \$125,000 with no costs borne by the City of Rapid City. The South Dakota Department of Transportation will utilize Transportation Enhancement funds for the project and the State Archeological Research Center will provide the required match.

The Planning Commission approved amendment #05-002 to the 2005-2009 Transportation Improvement Program on December 9, 2004.
