Subject: Issued Notice of Violation, failure to sample for oil and grease

Today, April 25, 2005 I checked with Chuck Larson, City Industrial Waste Program, and the violation was for the failure to monitor for oil and grease at the time of a discharge from our leachate aeration lagoon on September 17, 2004. I received a faxed copy of the publication at 8:42am today that states the public notice and Chuck's paper work. This was apparently caused by the error of the acting landfill supervisor at the time, Dan Roth, and also AET Engineering and Energy Lab to collect and sample for oil and grease before the discharge. There was confusion because on our storm water discharge permit, which is a different program entirely, we only test for oil, grease, or petroleum hydrocarbons when there is a visible oil sheen on the water. Apparently all parties involved made the same mistake, the oil and grease parameters were sampled at the net discharge and sample indicated compliance with all parameters. This was an error in procedure missed by our employee, the testing firm, and the lab. We happen to be testing the same source today for a discharge and I have been assured by the testing firm that the proper parameters were sample for and will be tested for.
