Council Members and Public Works Officials,

I write this letter as a citizen's request for support from the Rapid City Council. I have been awarded Tax Credit Financing for my Rapid Creek Apartments, a 54- unit affordable apartment development located on the west side of West Boulevard between Thrush and Anamosa Streets. Although I have already received a letter of support from the mayor's and planner's offices, South Dakota Housing Development also seeks approval from your body.

Rapid Creek Apartments will be a quality affordable housing alternative for families in Rapid City. It will include 46- Three Bedroom Apartment Homes and 8- Four Bedroom Apartment Homes. Each unit will include two bathrooms and a detached storage compartment. Clothes washers and dryers will also be included in each apartment. Additionally, each apartment home will include a garage. Each of these amenities is specifically targeted to the needs of families seeking quality affordable housing.

The recent South Dakota Housing Development Authority tax credit allocation round was competitive. Rapid Creek Apartments won for numerous specific reasons but mostly because it was a superior proposal. Besides the amenities to be offered, the property's affordability will be guaranteed for 30 years instead of the more usual 15 years. It will house families of Rapid City earning no more than 60% of the median income for this extended use period. Rapid Creek Apartments also won because it is located in a Qualified Census Tract, an area of Rapid City that is identified as in need of revitalization. Ultimately, Rapid Creek Apartments will provide a quality living experience to citizens of Rapid City who seek affordable housing and the property will prove a good neighbor to those living nearby.
