## ADDENDUM TO

  it in the original Agreement. This Addendum becomes effective

By the signature of their representative below, AGO, PCSO and RC certify that approval of this Addendum has been obtained by that governmental entity's governing body or officer pursuant to SDCL 1-24-3 and 1-24-6 by ordinance, resolution or other appropriate means, and that the representative is authorized to sign on that party's behalf. A copy of PCSO and RC's authorizing resolution or ordinance are attached to this Addendum and incorporated herein by reference.
