> the integrity of the land and our community. With respect to the  
> following issues I would encourage you to:

> 1) Deny the re-zoning of the 2 parcels of land in  
> question in the Tower Ridge area to General  
> Commerical. As you should already know, this is an  
> area of Recharge for the Inyan Kara Aquifer and there  
> is the same potential for contamination as in the  
> Sammis Trail Site. After 2 Zoning meetings, a  
> recommendation was not made and Mr. Hennies said it  
> was "unfair" for the Commission to consider a zoning  
> change without knowing of its intended use."

> This area should be independently studied regarding  
> "water safety plans" and "aquifer sensitivity" before  
> any further action is taken.

> 2) Encourage the preservation of the M Hill as it is  
> also part of our historical viewshed as well as the  
> Inyan Kara formation.

> 3) Say NO to Electronic Billboards which will clutter  
> up our beautiful greenway (proposed site along Omaha  
> and 3rd).
