### **RECOMMENDATION:**

Staff recommends that the Variance to the Subdivision Regulations to waive the requirement to allow a lot twice as long as wide as per Chapter 16.16 of the Rapid City Municipal Code be approved.

### **GENERAL COMMENTS**:

The applicant has submitted a Variance to the Subdivision Regulations to allow a lot twice as long as it is wide. In addition, the applicant has submitted a Layout Plat to subdivide the subject property into 276 single family residential lots, 64 townhome lots and one multi-family lot. The applicant has indicated that the development will be known as "Copperfield Vista Subdivision. (See companion item No. 06PL177.)

The property is located at the northern terminus of Copperfield Drive. Currently, the property is void of any structural development.

### STAFF REVIEW:

Staff has reviewed the Variance to the Subdivision Regulations and has noted the following considerations:

Lot Configuration: The Subdivision Regulations states that "...for lots in residential districts having a width of not more than one hundred fifty feet, the lot length shall not be greater than twice the lot width". The proposed Layout Plat identifies that 56 of the lots will have a length twice the distance of the width.

Twelve of the lots are located along the terminus of cul-de-sac streets. Due to the design of cul-de-sac streets, there is limited lot frontage along the roadway. The balance of the lots is located along the western and eastern portion(s) of the property. A water easement and a gas main easement, respectively, are also located along the rear lot line of these lots. No structural development is allowed within the easements. As such, the lots have been configured to incorporate the easements into the lots with building envelopes closer to the proposed street(s). The subdivision design as shown on this plat is reasonable for the site. In addition, the lot configuration does not create any significant difficulties for use or maintenance. As such, staff is recommending that the Variance to the Subdivision Regulations to allow a lot twice as long as it is wide be approved.

<u>Legal Notification Requirement</u>: The receipts from the certified mailings have not been returned. Staff will notify the Planning Commission at the November 22, 2006 Planning Commission meeting if this requirement is not met. Staff has not received any calls or inquires regarding this proposal.
