I now have an address that will allow me to transfer the license and when I went to begin the process was told the license is no longer valid.

I would like to know if there is any opportunity to get the license reinstated. I spoke with Carol at the State Department of Revenue and was told there was no issue on their end to have it reinstated; all taxes have been paid to date so it would be entirely in the cities hands. I know ignorance isn't a very good excuse but unfortunately it's all I have.
