SUBJECT: Revisions to the City of Rapid City Truck and Delivery Route Map.

DATE: December 7, 2006

In accordance with section 10.32.020 of the City of Rapid City Code of Ordinances, Common Council approval is requested for revisions and updates to the City of Rapid City Truck and Delivery Route Map.

BACKGROUND:

- 1) A copy of the proposed map is attached.
- 2) A summary of the proposed revisions is attached.
- 3) The current map was approved in 1998 and is being revised to account for changes in road jurisdiction, road improvement projects, City annexations, and development that have occurred since then.
- 4) The draft map was developed by representatives of Public Works, Growth Management, Police Department, and the City Attorney.
- 5) The proposed revisions were presented on October 3, 2006 to the Pennington County Board of Commissioners. The Board approved the City's inclusion on the map of a portion of county-jurisdiction Sheridan Lake Road (Rapid City city limit south to Dunsmore Road).
- 6) Two public meetings were held on October 25, 2006 and public comments were received up to November 9, 2006. No comments on the proposed changes were received.
- 7) The City of Rapid City Planning Commission at their December 7, 2006 meeting approved the draft map.

REQUESTED ACTION:

Staff requests that the Common Council approve the proposed revision of the City of Rapid City Truck and Delivery Route Map.

Fifth Street	Fairmont Boulevard to Omaha Street, remove from map (was delivery route)
I-90 & I-190	Add to map as truck route
Jackson Boulevard	Mountain View Road to Main Street, remove from map (was delivery route)
Lancer Drive	Remove from map (was truck route)
Main Street	Mountain View Road to Jackson Boulevard, remove from map (was delivery route)
Mall Drive	Haines Avenue to Elk Vale Road, add to map as delivery route
North Street	Cambell Street to I-90, change from truck route to delivery route
Saint Patrick Street	Cambell Street to SD-44, change from truck route to delivery route
Sammis Trail	US-16 to proposed unnamed rearage road, add to map as delivery route
Sheridan Lake Road	South city limit to Catron Boulevard, add to map as delivery route
