Total each property: \$92,484.53 - \$4800 - \$585 - \$5659.50 - \$1995 - \$33998.75 + \$14406.25 = \$59,852.53/5 = \$11,970.51

@40% of 59,852.53 = 23,941.01 therefore City Contribution = $4000 \times 5 = 20,000$ on sewer plus 4800 on 72" manhole plus 27,832 on paving, milling, gutter & traffic.

Property Owners Responsibility : \$92,484.53 - \$20,000 - \$4800 - \$27,832 = \$39,852.53 divided by 5 = \$7,970.51 each may be paid in full at determination of final assessment based upon construction cost or financed for 10 years @ 9% interest beginning at Council approval of Final Assessment.

The City shall pay \$27,380.00 out of sewer funds and \$20,847.97 from street funds. This is authorized by the "Common Utilities Matching Fund" resolution passed by the City of Rapid City November 7, 2005. Each benefiting lot shall be designated as receiving one equal benefit for the sewer main extension.
