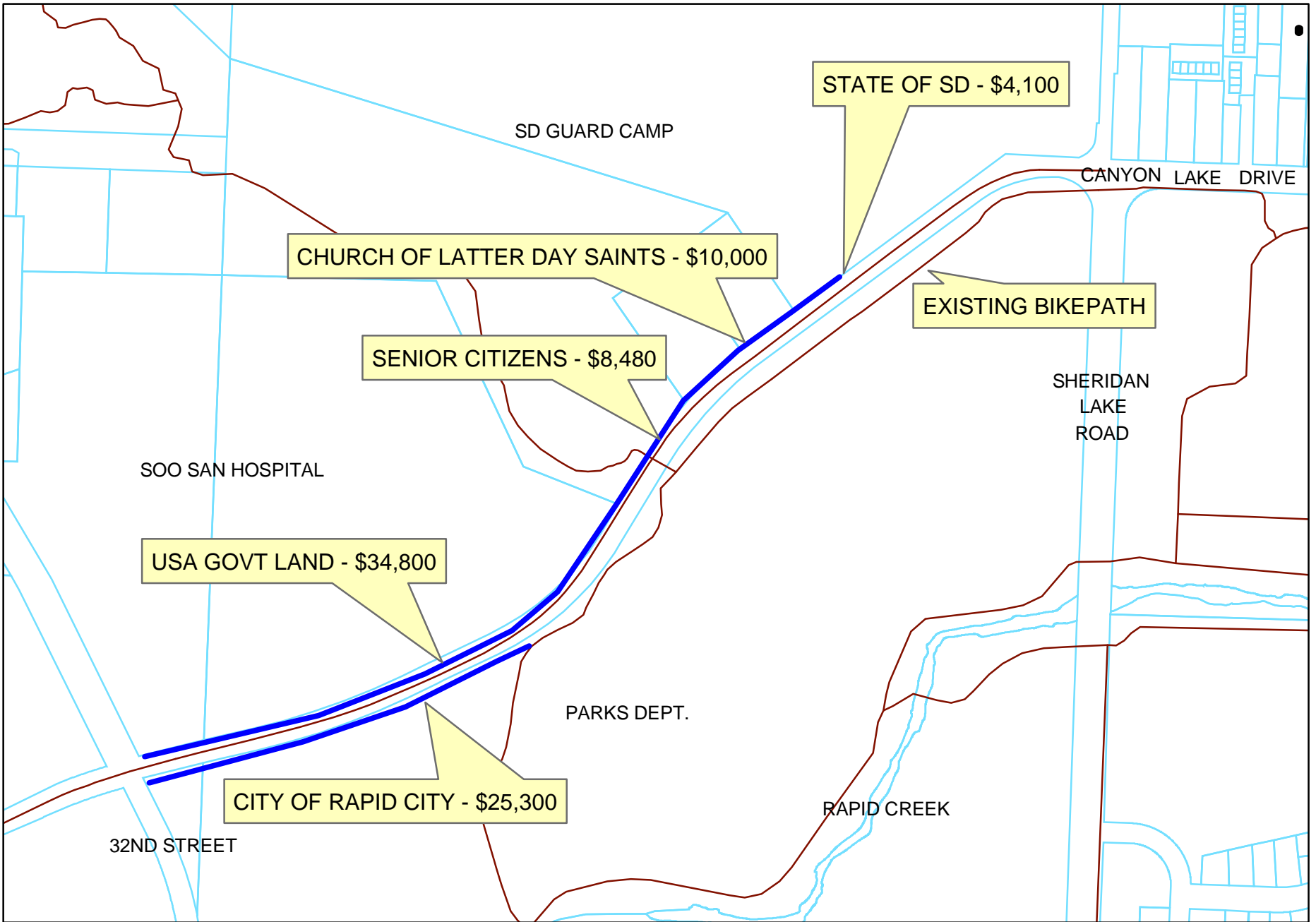

If the sidewalk is ordered in for this area, four property owners could be assessed approximately \$57,400. The City of Rapid City will incur costs of approximately \$25,300.

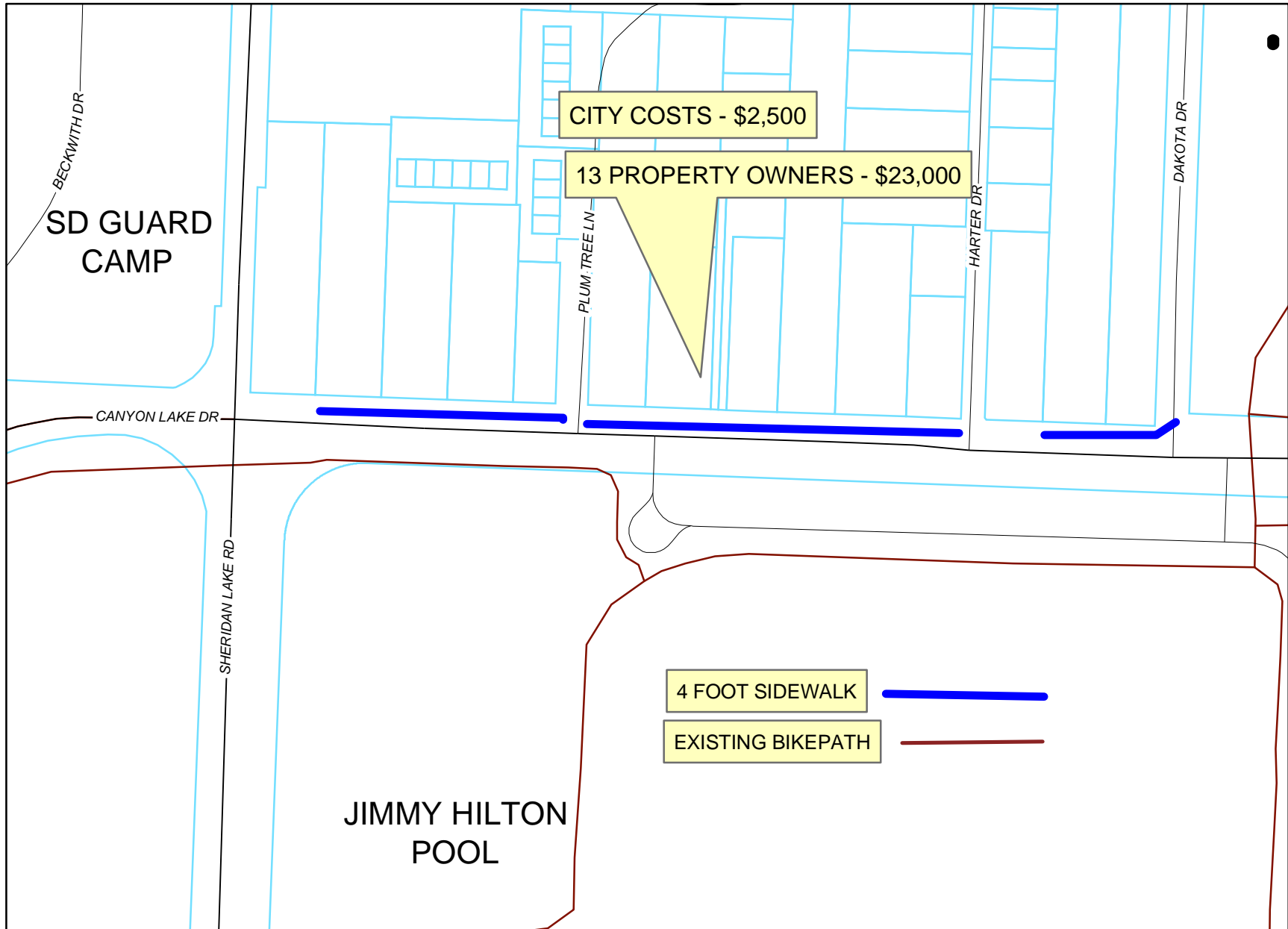

At the request of the complainant, Engineering Services requests that the City Council consider ordering in sidewalks in this area.

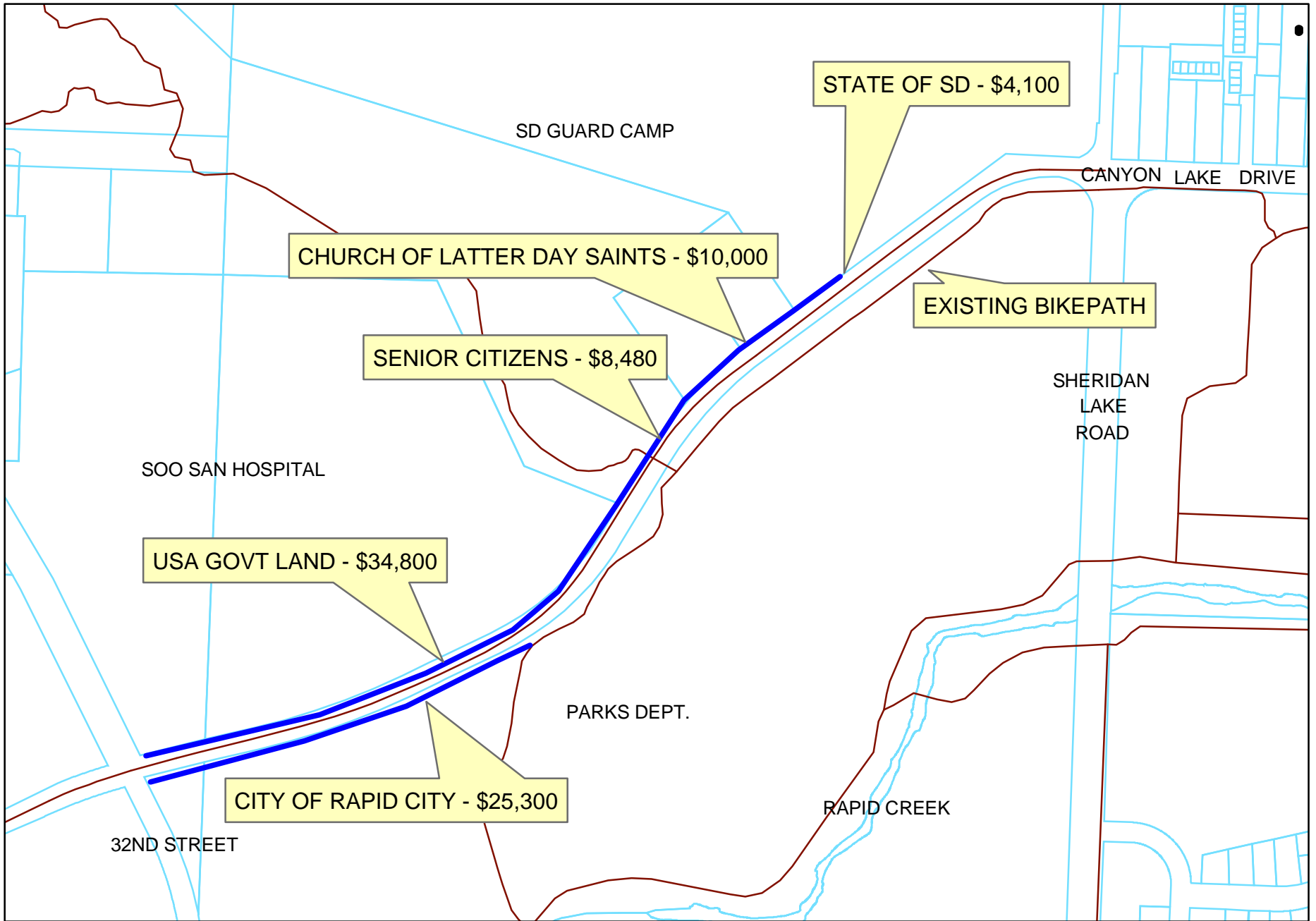
Thirteen property owners would be assessed approximately \$23,000. The City of Rapid City will incur costs of approximately \$2,500.
