Amendment to the City of Rapid City Healthcare Plan

Authorization is being requested for the Mayor and Finance Officer to sign Plan Amendment No. 2 to the City's healthcare plan. It is necessary to amend the City's Healthcare Benefit Plan to stay in compliance with changes to South Dakota Codified Law Sections 58-17-2.3 and 58-18-31.1 regarding eligibility to extend healthcare coverage to dependent unmarried children. Adoption of Plan Amendment Number will modify the plan so the City's Plan will be in compliance with the amended law effective July 1, 2007.
