

RESOLUTION LEVYING ASSESSMENT FOR
BLOCK 12 – MILLARD ADDITION SANITARY SEWER EXTENSION
PROJECT NO. SS06-1625
(Van Buren Street north between Halley and Blaine Avenues)

BE IT RESOLVED by the City Council of the City of Rapid City, South Dakota, as follows:

1. The City Council has made all investigations which it deems necessary and has found and determined that the amount which each lot or tract shall be benefited by constructing approximately 378 ft. of 8-inch sewer main is the amount stated in the proposed assessment roll.
2. The assessment roll for Block 12 – Millard Addition Sanitary Sewer Extension Project No. SS06-1625 (Van Buren Street north between Halley and Blaine Avenues) is hereby approved and assessments thereby specified are levied against each and every lot, piece or parcel of land thereby described.
3. Such assessments, unless paid within thirty (30) days after the filing of the assessment roll in the Office of the Finance Officer shall be collected by the City Finance Office in accordance with the procedure in Section 9-43-43 to 9-43-53 of the South Dakota Compiled Laws of 1967, as amended, and shall be payable in ten annual installments bearing interest at the rate not to exceed nine percent (9%).
