RECOMMENDATION:

Staff recommends that the Amendment to the Adopted Comprehensive Plan to change the land use designation from Public to Light Industrial be continued to the January 10, 2008 Planning Commission Meeting at the applicant's request.

- <u>GENERAL COMMENTS</u>: This undeveloped property contains approximately 104.189 acres and is located north of Seger Drive and west of Elk Vale Road. A large portion of this property is located in Zone A on the Federal Emergency Management Agency Flood Map. The property is currently zoned General Agriculture District by Pennington County. All of the land surrounding this parcel is zoned General Agriculture District by Pennington County. The adopted Long Range Rapid City Comprehensive Plan indicates that this property is appropriate for Public land uses with alternate land use designations of Low Density Residential, Light Industrial and Rural Reserve. The applicant has submitted this Amendment to the Adopted Comprehensive Plan to change the land use designation from Public to Light Industrial.
- <u>STAFF REVIEW</u>: The adopted Comprehensive Plan is a framework within which development and rezoning proposals are measured and evaluated. The plan is intended to guide the orderly growth of the community. In order for the plans to remain viable and to keep pace with a changing market place, periodic adjustments to reflect changing conditions will be required.

As noted the property is located in Zone A. The developer is in the process of submitting a conditional letter of map revision to the Federal Emergency Management Agency to remove portions of the site from the flood plain. To date, that application has not been submitted. The applicant has requested that this item be continued to the January 10, 2008 Planning Commission meeting to allow discussion of potential alternatives prior to consideration of the request.

Staff recommends that the Amendment to the Adopted Comprehensive Plan to change the land use designation from Public to Light Industrial be continued to the January 10, 2008 Planning Commission Meeting at the applicant's request.
