SUBJECT:

House Mover License- Russell Puckett, Medicine Root Development

Russell Puckett of Medicine Root Development has applied for the renewal of their house moving contractor license. During previous moves, the house mover cut trees and bushes and left a building in the right-of-way over night. Because of prior problems with Medicine Root Development, the Police Department and Growth Management staff recommends that the house mover license renewal application be denied. Medicine Root Development failed to meet the stipulations of a house move and did not follow the requirements set forth in the Moving of Buildings ordinance (RCMC15.08).

Staff Recommendation: Staff recommends denial of the moving contractor license renewal application for Russell Puckett, Medicine Root Development.

Re: House Moving Violation-No Future Permits

City of Rapid City police records revealed Medicine Root Development (License #51945) of Rapid City, SD has unpaid bills for police escort regarding recent house moves in the City of Rapid City. Due to these unpaid bills no house moving permits shall be issued to Medicine Root Development. Any future denied moving permit applications may be appealed to City Council.

Rapid City Municipal Code 15.08.060 states in part;

15.08.060 Violations Penalty

B. The Building Official, in his or her discretion, may refuse to issue a moving permit for the moving of any building or structure to be performed by any moving contractor if the moving contractor has failed to comply with the provisions of any other moving permits. Any moving contractor may appeal the decision of the Building Official to the Common Council.
