RE: Request for Waiving the Original and Late Fees for Debris Removal at 624 E Madison St.

On October 8, 2007 the City of Rapid City, mailed me the attached notice (attach. # 1) to remove debris, alleged from the property at 624 E. Madison. This notice was forwarded by the Rapid City Post Office on October 19 to my address in California and was received on October 21. Immediately I traveled to Rapid City on October 23, but the debris had already been removed between October 22 and 24. Much, much latter (December 11) the invoice #29041, for the amount of \$137.00 (attach. # 2) was mailed to me. I am respectfully requesting that the Rapid City Council waives this fee for the following reasons:

- 1. According to Ordinance 8.16.010 and 8.16.030 the City did not to give me (or the tenants) reasonable notice to allow me to remove the debris. This applies with, or without, the forwarding of the mail. Because of this I had one meeting with Mr. T. Kurtenbach on Thursday October 25 and then a meeting with Mr. T. Kurtenbach and Mr. Kevin Tom on Monday October 29. It was my understanding during this meeting that this matter had been taken care of, and as a consequence of that the potential invoice was not mailed.
- 2. As per enclosed statements of the tenants (attach. # 3) the debris, alleged did not come from the property at 624 E. Madison, but from the property adjacent to it. In addition the City does not provide any evidence that the alleged debris come from my property.
- 3. Independently of the correct origin the alleged debris they were not on my property (attach. # 4). The attachment #4 contains pictures taken by the City and these pictures clearly show that the debris is not on my property. In addition the City did not provide any evidence that the debris was at any time on my property.
- 4. I was thus very surprised when in December 2007 I received the invoice # 29041. Because of that another meeting was attempted with Mr. Kevin Tom and because he was not available a meeting was then scheduled with the Assistant City Attorney Mr. J. Landeen. During this meeting and based on the facts presented Mr. Landeen recommended that I appealed to the City Finance Committee and Ms. Maggie Paul graciously offered to assist with the process. Apparently during the preparation of the process to Finance Committee the matter was forwarded to the City Council with an additional fee of \$100 added to it, for a total of \$237.00.

Thus I am respectfully requesting that the Rapid City Finance Committee waives the original \$137.00 fee and the \$100.00 late fee assessed in this matter.
