The parties hereto agree that The Rawlins National Bank shall have no further contractual duty or obligation of any kind to the Mortgagors, or Obligors and Guarantors of any promissory note or security agreement as of the date of execution of this assignment, as said contractual obligation or duty may be set forth in the above mentioned Mortgage.
