


Thank you for the opportunity to provide you with this proposal for materials testing and inspection services to be performed for the above referenced project. This proposal consists of the narrative, scope of work, unit rates and estimated fee, and general conditions.

SCOPE OF WORK

American Technical Services will provide the necessary tools, equipment and personnel to perform soil field and lab testing and concrete field and lab testing for the **Roosevelt Park Improvement Project, Phase 3, in Rapid City, South Dakota.**

Field sampling and testing, laboratory testing, and on-site inspection will be conducted by experienced and qualified Engineering Technicians under the direct supervision of a Registered Professional Engineer. The proposed services will include on-site and laboratory testing as requested and specified to determine conformance of the following construction with the project specifications:

- o Soil analysis, acceptance and compaction testing below slabs, retaining walls, and structure backfill;
- o Field and laboratory concrete testing for structures, pavement, and slabs on grade.
- o Field and laboratory asphalt testing for pavement.
