Dear Mr. Titus:

As noted in our letter to you dated May 20, 2008, FourFront Design, Inc. requires an adjustment for providing additional construction administration services for the Red Rocks Reservoir Project. Enclosed please find a draft of Amendment No. 4 to the Agreement, including a breakdown of estimated labor hours to complete the project. Labor for close-out activities and landscaping subconsultant are not included; those costs have been budgeted for previously.

Heavy Constructors, Inc., projected in December that the project would be completed about May 1, 2008. However, for a variety of reasons beyond our control, the reservoir was not filled until the end of April, and approval for backfill around the tank was not given until June 9, 2008. Based on this date, we assume that backfill will be completed about mid-July and landscaping, fencing, demobilization, and final acceptance will be complete about mid-August. Our labor projection includes reduced time for observation during clean-up and completion tasks. We have also included labor hours for time associated with review of time extension requests and tracking of liquidated damage.

Dear Mr. Titus:

As you know, work on the Red Rocks Reservoir project is progressing slowly and anticipated schedules provided by the Contractor are not being met. The reservoir is presently full and the seven-day holding period is complete. We have observed excessive leakage through the base of the wall at one location and through the 16" drain valve. Therefore, the reservoir cannot be accepted and the project considered Substantially Complete at this point.

Please refer to the enclosed letter and spread sheet for Addendum No. 3 (to City-FourFront Agreement), dated December 7, 2007. At that time, we assumed that the reservoir would be filled and accepted about March 1 and project construction activities completed by May 1, based on a schedule provided by Heavy Constructors, Inc. It appears that, given the condition of the reservoir, corrective measures may take another month. Since backfill operations cannot begin until the reservoir is accepted, final close-out of the project will not occur for another two months after that.

To date we have expended most of the additional services budget provided for under Addendum No. 3. As the project continues well past the contract completion date of November 29, 2007, we require a contract adjustment for providing additional observation and CA services. We would like to submit and formalize another addendum as soon as possible. In the meantime, we will continue in good faith to provide observation and administration services to the City as required by our Agreement, and will continue to track liquidated damages being incurred by the Contractor. 
