MEMORANDUM

Re: Assessment Roll

Enchanted Pines Drive Water Main Extension

Project W07-1669

Submitted herewith is the Assessment Roll for costs associated with the above-referenced project.

I recommend that \$23,454.00 be accepted as the final construction cost of this project, and that a total cost of \$15,818.21 be assessed to the property owners. The costs to be assessed include net construction costs of \$14,072.40 (40% of construction costs were paid by the City through the Water Fund), six percent (6%) engineering fees (\$844.34), five percent (5%) fiscal fees (\$745.84), and interim construction finance fees of \$155.63. Benefiting equally, the assessment to each of the three (3) parcels is \$5,272.74.

Please see the attached Final Assessment Roll prepared by Engineering Services in accordance with the Resolution of Necessity.

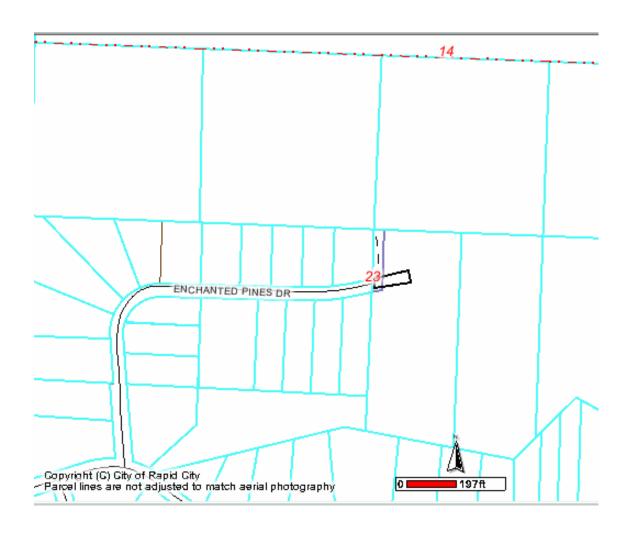
