Summary: The Cemetery Operations budget receives an annual subsidy from the General Fund.

Recommendation: Parks and Cemetery staff recommends a 5% increase in service fees as well as grave costs to help offset the general fund subsidy.

Analysis/Background: Increases in salary for both full time and seasonal employees, increase in fuel costs, utility cost increases and equipment maintenance costs increase each year. Competition with other local cemeteries and the inability to predict future "business" for the cemetery make revenue projections difficult. The trend for more Saturday funerals also increases the need for overtime pay for cemetery employees. Contractual services for gate security and weekend gate service has increased each year as well. The subsidy gap is also increasing as employee salaries increase. That subsidy narrowed a few years ago with a turnover in staff, but now is increasing each year.
