# RESOLUTION OF NECESSITY FOR THE ACQUISITION OF PUBLIC RIGHT OF WAY EASEMENT, WATER MAIN EASEMENT, UTILITY EASEMENT, MAJOR DRAINAGE EASEMENT, AND TEMPORARY EASEMENTS FOR ANAMOSA STREET THROUGH THE EXERCISE OF EMINENT DOMAIN

WHEREAS, the City of Rapid City has determined it is necessary to extend Anamosa Street from its current terminus east of Lacrosse to East North Street in order to facilitate public travel; and

WHEREAS, the City of Rapid City has determined that the acquisition of a right of way easement, water main easement, utility easement, major drainage easement and temporary construction easements for public use are necessary before the extension of Anamosa Street can occur; and

WHEREAS, the City of Rapid City has attempted to negotiate acquisition of the right of way and other easements and has been unable to secure said real property under agreeable arrangements; and

WHEREAS, the City of Rapid City is authorized to appropriate or damage private property for public purposes under the payment of just compensation as set forth in various provisions of state law including but not limited to SDCL §§ 9-12-1(2), 9-27-1;

NOW, THEREFORE, BE IT RESOLVED by the City of Rapid City that the Common Council of the City of Rapid City finds it necessary to take for the public purpose of constructing a City street along with other necessary appurtenant facilities the following described real property:

A portion of Tract A and the East Half (E½) of vacated Cherry Avenue of the Northeast Quarter of Section Thirty-one (31), Township Two North (T2N), Range Eight East (R8E) of the Black Hills Meridian, Rapid City, Pennington County, South Dakota, to be designated Lot H1, containing 38,799 square feet more or less, as shown on Exhibit "A", attached hereto and incorporated herein by reference;

A forty foot (40') wide water main easement over, under and across Tract A, in the Northeast Quarter of Section Thirty-one (31), Township Two North (T2N), Range Eight East (R8E) of the Black Hills Meridian, Rapid City, Pennington County, South Dakota, as shown on Exhibit "B", attached hereto and incorporated herein by reference;

An eight foot (8') wide utility easement over, under and across Tract A and the East Half (E½) of vacated Cherry Avenue in the Northeast Quarter (NE¾) of Section Thirty-one (31), Township Two North (T2N), Range Eight East (R8E) of the Black Hills Meridian, Rapid City, Pennington County, South Dakota, as shown on Exhibit "C", attached hereto and incorporated herein by reference;

A forty foot (40') wide major drainage easement over, under and across Tract A, in the Northeast Quarter (NE¼) of Section Thirty-one (31), Township Two North (T2N), Range Eight East (R8E) of the Black Hills Meridian, Rapid City, Pennington County, South Dakota, as shown on Exhibit "D", attached hereto and incorporated herein by reference; and

A temporary construction easement over, under and across Tract A and the East Half (E½) of vacated Cherry Avenue, in the Northeast Quarter (NE¾) of Section Thirty-one (31), Township Two North (T2N), Range Eight East (R8E) of the Black Hills Meridian, Rapid City, Pennington County, South Dakota, as shown on Exhibit "E", attached hereto and incorporated herein by reference.




## EXHIBIT A PLAT OF LOT H1




## EXHIBIT C 8' WIDE UTILITY EASEMENT


