RE: Authorize Mayor and Finance Officer to sign U.S Department of Housing and

Urban Development (HUD) Funding Approval/Agreement for Community Development Block Grant Funds for FY 2009 and to complete the Request for

Release for Funds and Certification.

Staff is seeking City Council authorization for the Mayor and Finance Officer to sign the U.S. Department of Housing and Urban Development (HUD) Funding Approval/Agreement for the Community Development Block Grant for FY2009.

HUD has awarded the City of Rapd City \$496,179 in Community Development Block Grant funds for FY 2009. In order to establish our Line of Credit to reflect the FY 2009 grant award, the City needs to execute three original copies of the Grant Agreement and complete the Direct Deposit Sign-up Form and return them to the U.S. Department of Housing and Urban Development (HUD) (forms are attached).

The FY 2009 CDBG funds will be utilized by the City and various non-profit organizations to provide services and housing to low income persons.

Staff Recommendation: City Council to authorize the Mayor and Finance Officer to sign three original copies of the HUD Funding Approval/Agreement for the Community Development Block Grant funds for FY 2009 and to complete the Request for Release of Funds and Certification for return to the U.S. Department of Housing and Urban Development (HUD).

## 13. (b) Special conditions:

## E. O. 12372 - SPECIAL CONTRACT CONDITIONS

1. Notwithstanding any provision of the Grant Agreement, no funds provided under this agreement may be obligated or expended for the planning or construction of water or sewer facilities until receipt of written notification from HUD of the release of funds on completion of the review procedures required under the Executive Order (E.O.) 12372, Intergovernmental Review of Federal Programs, and HUD's implementing regulations at 24 C.F.R. Part 52. The recipient shall also complete the review procedures required under E.O. 12372 and receive written notification from HUD of the release of funds before obligating or expending any funds provided under this agreement for any new or revised activity for the planning or construction of water or sewer facilities not previously reviewed under E.O. 12372 and implementing regulations.
