This Agreement outlines funding from the State in the amount of \$1,700,000 and the requirement that the City provide 18.05% in matching funds for this project.

AMENDMENT NO. 1 TO AGREEMENT NO 713770 BETWEEN SOUTH DAKOTA DEPARTMENT OF TRANSPORTATION AND CITY OF RAPID CITY

WHEREAS, on January 1, 2009, the State of South Dakota, acting by and through its Department of Transportation, hereinafter referred to as "STATE," and the City of Rapid City, South Dakota, hereinafter referred to as "CITY," entered into an Agreement for a greenway pedestrian and bike path extension High Priority Project number EM 8052(59) PCN 010E, which agreement, hereinafter referred to as "AGREEMENT," was signed by representatives of each party and assigned agreement number 713770 by the STATE; and,

WHEREAS, STATE and CITY wish to amend the AGREEMENT;

NOW, THEREFORE, the parties mutually agree as follows:

Paragraph A.2 shall be revised to read as follows:

 Reimburse CITY 81.95% for eligible PROJECT costs with HPP Funds up to a maximum of One Million, Eight Hundred Twelve Thousand, Two Hundred Seventy-eight Dollars and Ten Cents (\$1,812,278.10). The remaining 18.05% and any amount exceeding the maximum amount of HPP funds shall be paid by the CITY.

CITY and STATE agree that all other terms of the original AGREEMENT shall remain in full force and effect.

The CITY has designated its Mayor as the CITY'S authorized representative and has empowered its Mayor with the authority to sign this Amendment on behalf of the CITY. A copy of the CITY'S Commission minutes or resolution authorizing the execution of this Amendment by the Mayor as the CITY'S authorized representative is attached hereto as Exhibit 2
