This is in response to your request for affirmation of your organization's exempt status.

In November 1942 we issued a determination letter that recognized your organization as exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect.

Denots may deduct contributions to your organization's subordinates as provided in section 170 of the Code. Baquests, legacies, devises, transfers or gifts to the subordinates or for their use are deductible for federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2105, and 2522 of the Code.

Your organization and its subordinates are required to file Form 990, Return of Organization Exampt from income Tax, only if the gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed (ate, unless there is reasonable cause for the delay.

Your organization and its subordinates are not required to file faderal income tax returns unless subject to the tax on unrelated business income under section 511 of the Code. If subject to this tax, the organization must file an income tax return on Form 990-T, Exempt Organization Business income Tax Return.
