#### **RECOMMENDATION:**

Staff recommends that the Rezoning from No Use District to General Commercial District be approved.

GENERAL COMMENTS: The property occupies approximately 6.15 acres and is located at 2000 Lancer Drive, west of Elk Vale Road and north of S.D. Highway 44. The property was annexed into the City limits (#08AN011) effective June 4, 2009 and subsequently zoned No Use District. Land located to the north is zoned General Commercial District. Land located to the south is owned by Pennington County for drainage purposes. Land located to the east is zoned No Use District. Land located to the west is zoned General Commercial

District with a Planned Commercial Development. Lord of Life Lutheran Church is currently located on the property.

The Elk Vale Neighborhood Future Land Use Plan identifies the future use of the property as appropriate for General Commercial land use.

STAFF REVIEW: Staff has reviewed this proposed rezoning for conformance with the four criteria for review of zoning map amendments established in Section 17.54.010(D)(1). A summary of staff findings are outlined below:

1. The proposed amendments shall be necessary because of substantially changed or changing conditions of the area and district affected, or the City in general.

A City initiated annexation of the property (#08AN011) was effective June 4, 2009. Per Section 17.26.020, all annexed lands are temporarily designated No Use District. The annexation of the property represents a changing condition that requires the rezoning of the property.

2. The proposed zoning is consistent with the intent and purposes of this ordinance.

The General Commercial Zoning District is intended to provide for personal and business services and the general retail business of the City. The property is currently being used for a church, a permitted use in the General Commercial Zoning District. The property was zoned General Commercial District by Pennington County prior to annexation. Commercial land uses are located on adjacent properties to the north and west. Due to the land uses on adjacent properties, the rezoning of this property appears to be consistent with the intent and purposes of this ordinance.

3. The proposed amendment will not adversely affect any other part of the City, nor shall any direct or indirect adverse effects result from such amendment.

The property is accessed from Concourse Drive, a minor arterial on the Major Street Plan, and by Lancer Drive, a local street. Water and sewer services are provided by Rapid Valley Sanitary District. The property is currently being used for a church, a permitted use in the General Commercial Zoning District. The property is located adjacent to existing commercial land uses. Staff has not identified any adverse impacts that would result from the requested rezoning.

4. The proposed amendment shall be consistent with and not in conflict with the development plan of Rapid City including any of its elements, major road plan, land use plan, community facilities plan, and others.

The Elk Vale Neighborhood Future Land Use Plan identifies the future use of the property as appropriate for General Commercial land use. Rezoning the subject property from No Use District to General Commercial District is consistent with the adopted Comprehensive Plan.
