
Dear Renner and Associates:

Dear Mr. Renner:

The Request for Exception to the Drainage Criteria Manual, to waive the requirement to meter storm water flows to historic rates is denied. The intent of the Drainage Criteria Manual is mitigate the impact from uncontrolled stormwater runoff in urbanized environments. The requested exception will allow development of the property without detention and the downstream impacts could result in increased stormwater runoff, soil erosion, sedimentation and a negative impact on storm water quality. Please note that stormwater treatment is not required at this time as the increase in impervious area does not exceed 15%.

The denial of this exception request may be appealed to the City Council by requesting it be placed on the next Public Works Committee agenda. Please contact the Growth Management Department if you desire to appeal. The City Council has final approval of exception requests.
