The board shall consist of ten owners of property within the business area, who shall be appointed by the Mayor and confirmed by the Common Council. Of the ten, six shall own property within Zone 1 and four shall own property within Zone 2. A single property owner who owns property in both zones may be appointed to represent either zone. A property owner includes the following:

- 1. An officer or director of a corporate property owner;
- 2. A manger or member of a limited liability company that owns property; or
- 3. A partner of a partnership that owns property

Upon initial appointment, one-half of the members representing each zone shall be appointed for two-year terms, and one-half shall be appointed for one-year terms. Thereafter, all members of the board shall be appointed to serve a two-year term. A member of the board may serve more than one term.
