RESOLUTION #2010-092 A RESOLUTION ESTABLISHING THE PRIORITY LIST FOR ALLEYS TO BE PAVED USING "OUT OF THE DUST" FUNDS.

WHEREAS, in 1988, the City Council of the City of Rapid City adopted a policy to dedicate a portion of the additional ¹/₂ cent of the City's sales tax dollars to assist landowners pave otherwise unpaved streets and alleys within the City; and

WHEREAS, on May 3, 2010, the City Council modified the policy by removing the requirement landowners participate in the paving projects; and

WHEREAS, the City Council further directed that staff annually prepare a priority list of alleys which will be paved using the "Out of the Dust" funds; and

WHEREAS, subject to an annual review and modification by the City Council, the staff of the City's Public Works Department has compiled a list of paving projects which have been prioritized over a five year period.

NOW THEREFORE, BE IT RESOLVED, by the City of Rapid City, that the City Council approves the following priority list for alleys being paved with funds from the City's "Out of the Dust" Program:

Alleys proposed for 2010-2011:

- Mt. Rushmore Road to 7th Street, Saint Charles Street to Saint Andrew Street
- Herman Street to Milwaukee Street, E. Van Buren Street to E. Jackson Street
- > 11th Street to West Boulevard, Saint Cloud Street to Franklin Street
- ▶ 12th Street, Fairview Street to Saint James Street
- Farlow Street to Haines, Monroe Street to North Street

Alleys proposed for 2012-2014:

- Farlow Street to Haines, Nowlin Street to Custer Street
- Halley Avenue to Holcomb Avenue, Anamosa Street to College Avenue
- Farlow Avenue to Haines Avenue, Custer Street to Van Buren Street
- Farlow Avenue to Haines Avenue, Van Buren to Adams Street
- Farlow Avenue to Haines Avenue, Adams Street to Monroe Street

- N. Maple Avenue to Herman Street, E. Denver street to E. Philadelphia Street
- ➤ West Boulevard to 9th Street, Saint Francis Street to Flormann

BE IT FURTHER RESOLVED, the City Council recognizes actual construction of the paving projects is based on the availability of funding. Should sufficient funding not be available for the next project on the list, the project will be delayed until there is sufficient funding. The Public Works Director, or their designee, may authorize staff to proceed with lower priority projects on the above list for which there is sufficient funding if there is not sufficient funding to proceed with higher priority projects.
